### Scope of work

- 1. Furnish and install fire sprinkler systems per NFPA and AHJ minimum requirements

  - a. Wet sprinkler system for core and shell of building

### Water entry room

- 3. Start all work at a flanged connection at interior of Valve Room. Fireline shall be inspected and flushed by others per NFPA standards prior to connection by FFP
- 4. Install double check backflow preventer and provide required certifications
- 5. Install fire department connection on exterior wall of valve room

### **Design and installation**

  - a. Offices, corridors, restrooms and similar area = Light Hazard
