Board Action Needed: Motion to approve slate of meeting dates and times as well as notification in window of LDDA office.

Agenda Item: Legislative Consulting Services

Executive Summary: During the budget process for 2023, the LDDA Board allocated \$25,000 toward a shared contract with Grand Junction DDA (GJDDA) and Fort Collins DDA (FCDDA) to hire a consultant to provide ongoing advocacy and lobbying services at the Colorado legislature, administrative departments and the executive branch.

Together we extended requests to four consulting firms for proposals. In October, it was collectively decided that Politicalworks of Denver, led by Travis Berry and Scott Chase, was best suited to provide this joint service to the three DDAs.

Attached is a draft of the contract, including the scope of services from Politicalworks. The total amount for the contract is \$60,000 for a nine-month period. We propose this amount be split equally among the three partners, \$20,000 each.

Our attorney has reviewed the contract and has a few minor revisions. He will work with legal counsel for FCDDA and GJDDA to incorporate those into the final agreement.

Motion: Approve agreement with Politicalworks, LLC for costs up to \$20,000, with changes as agreed upon with legal counsel and executive director.

Agenda Item: Joint DDA - Council Meeting Agenda

Executive Summary: On January 10th, the LDDA Board will be meeting with City Council at a pre-session. The Board requested this meeting to discuss the need for improvements and investments in connectivity and access, particularly in regard to pedestrian infrastructure.

As the Board continues to implement the community-driven vision of our Master Plan of Development, a focus on connectivity and access is the highest priority. The adopted vision states:

Access to Downtown is easy, safe and low-stress for people living, working or visiting by any form of transportation; understanding the almost every person is a pedestrian at some point of their trip to Downtown.

As we continue to implement the Plan, now is the time to make necessary transportation investments and strategies to ensure a positive experience for the whole community. The City's critical initiative in the 1st and Main Transit Area will catalyze the community's vision of embracing alternative transportation and bringing more pedestrians into the downtown area. Also, in November, the Council voted to move forward with Vision Zero policies and implementation.

In the recently passed 2023 budget, LDDA funded \$500,000 (\$250,000 in both 2023 and 2024) in the Capital Improvement Program (CIP) Main Street Corridor Plan (TRP137) budget, which addresses speed mitigation, mid-block crossing improvements and alley reconstruction.

Our request to City Council was to discuss timelines, goals and how we can work together to maximize the DDA budgeted funds to take action and make the City safe and comfortable for pedestrians of all ages and abilities.
