CR is to provide written notice to customers upon learning of the price increase and provide documentation of the price of the material as of the date of this contract and the revised price. Similarly, if the price of a material decreases, CR shall provide a credit equal to the reduction in purchase price between the cost of the material as of the date of this contract and purchase price upon request.
- 4. Approval. All proposals are subject to approval by CR management.
- 5. Right of First Refusal. Owner grants CR an exclusive right of first refusal on any final estimate generated by the insurance company (ies).
- 6. Material Selection. Owner is solely responsible for the material and color selection of all products utilized by CR and agrees to ensure that all such selections shall meet or exceed any neighborhood, city, homeowners' association, zoning, master leases, building code or any person, group or entity concerning the quality, type, color or other characteristic of the material selected by Owner.
