7. I give permission for my and/or my minor child(ren)'s picture to be taken during this event and allow the LDDA to use it in promotional materials including hard copy and electronic.
8. This Acknowledgement of Risk and Release is valid for a period of 5 years from the date executed below.

While serving as an Authorized Volunteer for the benefit of and involved in the activities at the request of the Longmont Downtown Development Authority volunteers are provided the protection of the Colorado Governmental Immunity Act Section 24-10-101 (et seq.) and are subject to the applicable provisions of the Act. The Act does not cover any willful and/or wanton behavior including, but not limited to, sexual harassment, racial or gender discrimination, drug and/or alcohol use.
