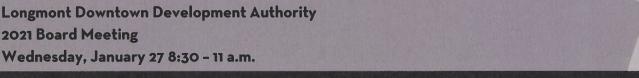

APPROVAL OF MINUTES

Motion to approve the December 16, 2020 Board Minutes: John Creighton moved to approve the minutes, Kirsten Pellicer seconded the motion. The motion passed unanimously.

110 Emery Incentives – Retail Conversion & Façade Grant

Brian Bair of the South Main Station development is applying for 2 grants for 110 Emery, the spice building of the former Butterball. Construction will take approximately 90-120 days. His total application for a retail conversion grant is \$15,000 and total façade grant is \$10,000. A tenant will occupy the space, Dee-O-Gee, a pet boutique style business to include food, daycare and grooming.

Motion: John moved to approve \$25,000 for retail conversion and façade grants, Chris McGilvray seconded the motion. The motions passed unanimously.

Brian added the SMS is now 79% occupied.

Motion: Chris McGilvray moved to approve letter of approval for Dryland Distillers to use 500 West breezeway, Wes Parker seconded the motion. The motion passed unanimously.

EXECUTIVE DIRECTORS REPORT

Firehouse artist in residence will work on a mural and needs to identify a wall for this. The LDDA will pay 25% of project to offset funding. If project goes more than \$5,000 the board agreed to allow staff to approve additional funding, in accordance with the terms and conditions of the DIP grant.
